Limited Warranty Certificate

Except as stated below, ASM Modular Systems, Inc. (hereinafter known as "Seller" or "ASM") warrants that all products manufactured and supplied by Seller to Buyer will be free from defects in material and workmanship under normal use and service for a period of one (3) year from the date of completion. Seller warrants components supplied by others and incorporated into the Seller's products only to the extent of the express warranties made by the suppliers of such components.

This limited warranty extends only to the original end user purchaser of Seller's products and does not cover normal wear and tear of parts or damage or loss resulting from misuse, accident, neglect, improper installation or maintenance. In order to qualify for this warranty coverage, Buyer must install, use and maintain the Seller's products strictly in accordance with the instructions and recommendations contained in Seller's literature.

If Buyer claims that the Seller's products do not conform to this limited warranty, it must, affeller's option, either return any defective part(s) to Seller with freight or other transportation costs prepaid or allow Seller's personnel to inspect the Seller's products at the site of their installation or use. If, after inspection, Seller determines the Seller's products do not conform to this limited warranty, Seller in its sole discretion will choose to (a) repair the Seller's products without charge to Buyer, (b) replace the Seller's products without charge to Buyer, or (c) repay the purchase price to Buyer. The warranty period for repaired or replaced components shall be the remainder of the original warranty period.

THE WARRANTY SET FORTH HEREIN IS THE ONLY WARRANTY PROVIDED BY SELLER AND IS STRICTLY LIMITED TO ITS TERMS AND IS IN LIEU OF ALL OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR OTHER WARRANTIES OF QUALITY, AND OF ALL OTHER LIABILITIES AND OBLIGATIONS, ALL OF WHICH ARE HEREBY DISCLAIMED. BUYER HEREBY WAIVES ALL OTHER CONDITIONS, REPRESENTATIONS AND WARRANTIES, EXPRESS OR IMPLIED BY STATUE, USAGE, CUSTOM OF THE TRADE OR THERWISE. NOTWITHSTANDING ANY PRIOR STATEMENT, WRITTEN OR ORAL, SELLER MAKES NO OTHER WARRANTIES REGARDING THE QUALITIES OF IT PRODUCTS OR THE MATERIAL INCORPORATED THEREIN.

Buyer understand and agrees that in no even shall Seller be liable to Buyer or to any third party for any incidental, special, consequential or other similar damages arising, directly or indirectly, out of or occasioned by the purchase, use, installation, repair, replacement of the Seller's products, whether such damages are based on a claim for breach of express or implied warranty, tortuous conduct, or any other cause of action, whether or not foreseeable and whether or not Seller has been advised of the possibility of such damages. Under no circumstances will Seller's liability exceed the purchase price paid by Buyer for the Seller's products<u>BUYER SPECIFICALLY UNDERSTANDS AND</u> <u>AGREES THAT ITS SOLE AND EXCLUSIVE REMEDY FOR BREACH OF WARRANTY, TORTIOUS CONDUCT OR ANY OTHER CAUSE OF ACTION AGAINST SELLER IS THE REMEDY OF REPAIR, REPLACEMENT OR REFUND PROVIDED HEREIN.</u>

This limited warranty shall be construed and the obligations of Seller shall be interpreted in accordance with the laws of the Stated of New York without regard to the conflicts of laws thereof. Any dispute arising under this limited warranty shall be brought in such New York state or federal court as has subject matter jurisdiction.
